

**UNITED CHURCH OF RELIGIOUS SCIENCE
UNITED CENTERS FOR SPIRITUAL LIVING
INSIGNIA AGREEMENT**

NOW THEREFORE, the Member - Special Focus Ministry Organization (s), Teaching Chapter agrees with each of the other Member Churches, Teaching Chapters and Special Focus Ministries of the United Church of Religious Science /dba/ United Centers for Spiritual Living and with the United Centers for Spiritual Living, (referred to herein as United Centers for Spiritual Living) as follows:

1. The Member shall be entitled to use said marks, as hereinafter provided, during the time that the Member is an Affiliated Member of the United Centers for Spiritual Living.
2. The Member further agrees that on termination of such affiliation, it will immediately destroy all unused property in its possession on which said marks are depicted, including all means of reproducing said marks, and it will immediately notify all members of its congregation and businesses with which it regularly does business of such termination of membership or withdrawal of recognition and authorization.
3. Said marks shall be depicted only as set forth in Exhibit 1 and in no other way.
4. Said marks may be affixed or depicted only in connection with the following:
 - a. Official stationary, office forms, membership forms and other like items used by the Member.
 - b. Published announcements of the Member.
 - c. Books, magazines, newsletters and other like items used or published by the Member.
4. Said marks shall not be depicted standing alone. The full name of the Member must be set forth in a straight line in close proximity thereto and associated therewith.
5. Each church, hereafter becoming an Affiliated Member Church, Teaching Chapter or Special Focus Ministry of the United Centers for Spiritual Living shall be entitled to use said marks. Such entitlement shall be established by execution of an agreement substantially identical to this Agreement with Paragraph 8 hereof, by each such church hereafter becoming an Affiliated Member of the United Centers for Spiritual Living.
6. The rights granted to the Member by this Agreement are not assignable voluntarily or by operation of law. Any attempted assignment shall be null and void.

- 7. Said marks may be registered by the United Centers for Spiritual Living under the Lanham Act and under applicable state laws and cannot be so registered by the Member.

INSIGNIA AGREEMENT (continued)

- 8. In recognition of the general authority of the CORE Council of the United Centers for Spiritual Living, this Agreement may be amended or supplemented from time to time by the CORE Council of the United Centers for Spiritual Living relating to fixation and depiction of said marks. Any such amendment or supplement shall be binding on the Member, except that if the Member does not wish to be bound by any such amendment or supplement, it may, as an alternative, permanently discontinue use of said marks by giving notice of such discontinuance to the United Centers for Spiritual Living.
- 9. The Member acknowledges that it derives its right to use said marks solely through the United Centers for Spiritual Living and this Agreement, and not otherwise.
